Institute Level Admission Round for Vacant Seats of B. Tech First Year Engineering 2024-25

Institute Level Admission Round for filling the CAP vacant seats as per Sr. No. 13 of Admission Brochure of First Year Engineering for the academic year 2024-25 is scheduled on 12/09/2024. Interested candidate having application ID EN24-----may apply for this round.

Late registration on 12/09/2024 after 11.30 AM. will not be considered for institute level round.

Schedule of Admission Activities :

- (i) **Institute Level Admission Round Date : 12/09/2024 (Thursday)**
at Room No. 2(Conference Hall)
- (ii) **Registration:**
 - **Registration time : 9.30 am to 11.30 AM(No late registration is allowed).**
 - Registration is compulsory by paying the registration fee –**Rs. 200/-** for all categories. Fee should be paid at **Cash Counter** of the institute.
 - Fill the application form in the prescribed format and submit it to collection counter before 11.45 AM.
- (iii) **Display of Provisional Merit List:** On Office Notice Board at **1.00 pm**
- (iv) **Grievances:** Period for clearing the grievances, if any:-**1.00 pm to 1.15 pm**
- (v) **Commencement of Round:** 12/09/2024 at **1.15 pm onwards.**

Instructions:

- Eligible candidate as per displayed Provisional merit list must remain present in **person** along with necessary documents and fees prescribed.
 - ✓ All original documents or Original Admission Confirmation Receipt of CET Cell or **Bonafide Certificate.**
 - ✓ Three set of attested photocopy of all documents mentioned in Scrutiny Centre acknowledgement receipt.

- Admission Fees will be accepted through online payment mode (SB Collect) at the time of confirmation of admission.
- If candidate is reported late for counselling, then he/she will not be considered for the previously allotted seat. He/she will be considered for admission round at that time. In no case candidate claim for earlier seats will be entertained due to late reporting.
- If any interpretation or change in schedule is reserved with college authority.
- If any vacancy created after completing the institute level admission round and in due course of time, such vacant seats will be filled in, from the waiting list, **on 13/09/2024 at 12.00 noon.**

ADMISSION PROCEDURE

- Category wise vacancy position will be displayed as and when vacancy created during admission process.
- The number of vacant seats of respective branches may vary during allotment process.
- The candidate should confirm admission to allotted seat by payment of full fees and submission of necessary documents, otherwise seat will be allotted to the next candidate in merit list. (Admission will not given on receipt of NCL, EWS, CVC/TVC applied).

Admission will be conducted in two stages.

(A) First stage will be conducted as follows:

As per inter-se-merit list, the candidates from the same category for which it was earmarked for that category shall fill in.

(i) Vacant CAP seats with HU and OHU tag and

(ii) If seat remain vacant after completing round A (i) then same will be executed without HU and OHU tag of respective category.

If particular seat of this college is vacated by securing the seat in this part, the same will be available to next candidate of that particular category it was earmarked, as per inter-se-merit. After exhausting the merit list of first stage, then remaining vacant seats will be filled in from inter-se-merit and second stage admission round will start (**All seats will be treated as open without any tag**).

(B) Second stage round will be conducted as per inter-se-merit.

If any vacancy created during this round due to change of branch, the seat will be available to next candidate in the inter-se-merit list.

If any vacancy created after completing second stage of institute level admission round and in due course of time, such vacant seats will be filled in, from the waiting list, **on 13/09/2024 at 12.00 noon.**
